

Terms and Conditions

1. The Promoter is Valor Hospitality Europe Limited (Company Registration Number SC481196) of St James House, 3rd Floor, South Wing, 27–34 Eastern Road, Romford, Essex RM1 3NH, acting as agent on behalf of PPC Hospitality UK Limited and HICP Limited (together, the "Principals"). The Promoter and the Principals shall be jointly responsible for the administration of this promotion.
